Club Fees

Policy and Procedures Manual - 410

The Pioneer Archers are committed to providing a safe environment for the participation of athletes and spectators whether they be members, their families and friends, and other sporting personnel while attending an event.

410. Club Fees

- a) Pioneer Archers being an affiliated Club to Archery Australia (AA) and Archery Western Australia (AWA), acknowledge through our constitution that every member of the club must be affiliated to both our state and national governing bodies.
- b) Annual subscription date:
 - i) All members of Pioneer Archers must pay their subscriptions which will fall due on the archer's anniversary date.
 - (1) For Foundation members who were affiliated with AA/AWA prior to the association's date of incorporation, being 3 April 2012, the anniversary date will be 1 January or as otherwise advised by AA or AWA.
 - (2) For members of the association who joined after the date of incorporation, the anniversary date will be the date of joining the association.

c) Annual Subscription Rates:

- i) Consistent with the requirements of the Associations constitution the amount of the annual fees will be set by a general meeting of the members and will be applicable from the date nominated at that meeting.
- ii) There will be a club fee for a shooting member who is under the age of 18 years and a club fee for a shooting member who is 18 or older.

The club fee for a shooting member who is 18 years or older is set at \$50.00

The club fee for a shooting member who is under 18 is set at \$30.00

The club fee for a non-shooting member is set at \$3.00

- iii) Members will pay the amount of the club subscription fee due, based on their age at the time of joining the club or their anniversary date.
- iv) Each member will also be required to pay the annual subscription fee to AA and AWA, (See Schedule 1) in addition to the prescribed club fee.

Example:

Male aged 30 years on the day that they join the association as a shooting member will be required to pay:

d) Target Fees:

- i) Each archer will pay a target fee when shooting at the club. The fee will be set at a general meeting of the members; the fee is currently set at \$10.00 (Cash) or \$8.00 (EFT).

ii) The cash fee is based on the following proportional distributions

iii) The EFT fee is based on the following proportional distributions;

a) Visitor Target Fee:

- i) Affiliated archers from Intrastate and Interstate who visit the club on the regular programmed day will be required to pay the current weekly target fee.
- ii) Non-affiliated archers who attend the club and wish to shoot as a Temporary Player, as defined under the Archery Australia rules, will be required to pay 150% of the current weekly target fee, plus the required fee for Temporary insurance coverage.
- iii) The Committee of Management are authorised to vary the amount of the Weekly Visitor fee for special occasions.

b) Qualifying Ranking Event (QRE) Target Fees:

- i) Archers attending an association organised QRE on any day other than the normal programmed Saturday calendar shoot, will only be required to pay the total amount of weekly target fees components A, B and C.
